BYLAW NO. 11-2010

A BYLAW TO AUTHORIZE ENTERING INTO AN AGREEMENT WITH OTHER MUNICIPALITIES TO FORM THE MOOSE JAW-REGINA INDUSTRIAL CORRIDOR STAKEHOLDERS COMMITTEE

WHEREAS, the City of Regina, the City of Moose Jaw, the Village of Pense, the Village of Grand Coulee, the Village of Belle Plaine, the Rural Municipality of Moose Jaw No. 161, the Rural Municipality of Pense No. 160 and the Rural Municipality of Sherwood No. 159 wish to establish an inter-municipal advisory committee to develop and oversee the implementation of regional development strategies for the Moose Jaw-Regina Industrial Corridor; and

WHEREAS, the City of Regina, the City of Moose Jaw, the Village of Pense, the Village of Grand Coulee, the Village of Belle Plaine, the Rural Municipality of Moose Jaw No. 161, the Rural Municipality of Pense No. 160 and the Rural Municipality of Sherwood No. 159 have been meeting informally to investigate the potential to work together for the growth, marketing and sustainability of the Corridor; and

WHEREAS, the City of Regina, the City of Moose Jaw, the Village of Pense, the Village of Grand Coulee, the Village of Belle Plaine, the Rural Municipality of Moose Jaw No. 161, the Rural Municipality of Pense No. 160 and the Rural Municipality of Sherwood No. 159 desire to maintain an agreement between the municipalities for the operation of the planning committee and the implementation of its plan;

NOW THEREFORE, the Council of the Rural Municipality of Pense No. 160, in the Province of Saskatchewan, enacts as follows:

1. It shall be lawful for the council of the Rural Municipality of Pense No. 160 to enter into an Agreement among the municipalities set out below for the purpose of forming the Moose Jaw-Regina Industrial Corridor Stakeholders Committee and to set out the terms and conditions for the operation of such Committee, the Agreement to be annexed to this Bylaw and marked as

SCHEDULE A:

- a) City of Regina;
 - b) City of Moose Jaw;
 - c) Village of Pense;
 - d) Village of Grand Coulee;
 - e) Village of Belle Plaine;
 - f) Rural Municipality of Moose Jaw No. 161;
 - g) Rural Municipality of Pense No. 160;
 - h) Rural Municipality of Sherwood No. 159.
2. The Reeve and Administrator are hereby empowered and directed to sign and seal such agreement, and to do all things necessary for the carrying out of the terms and conditions outlined in such agreement.
 3. This Bylaw shall come into effect and force upon the final passing thereof.
