


BYLAW NO. 07-2013

A BYLAW TO PROVIDE FOR THE NUMBERING OF
HOUSES AND OTHER BUILDINGS IN THE HAMLETS

The Council of the Rural Municipality of Pense No. 160 in the Province of Saskatchewan enacts as follows:


1. This bylaw shall be referred to as the Civic Addressing Bylaw.
2. A uniform system of numbering houses and other buildings is hereby established and is shown on the attached maps identified as Schedule "A" and Schedule "B", appended hereto and forming a part of this bylaw.
3. A separate number shall be assigned for each 25 feet (7.62 meters) of frontage.
4. Each house or building shall bear the number assigned to the frontage on which the front entrance is situated.
5. Notwithstanding section 4 of this bylaw, upon request of the owner of a property situated on a corner, the number assigned may be specific to the flankage.
6. In case a house or building is occupied by more than one family dwelling or unit or business, each separate front entrance of said house or building shall bear the same number extended with a letter of the alphabet beginning with the letter "A" and proceeding with as many as are required.
7. Numerals indicating the official number of each house or building or each front entrance shall be posted in a manner as to be visible from the street on which the property is located.
8. The Administrator shall be responsible for maintaining the numbering system and shall keep a record of all numbers assigned under this bylaw.
9. Any person who contravenes the provisions of this bylaw is guilty of an offence and upon conviction shall be liable as per the General Penalty Bylaw.


