Simpson: WHEREAS the Rural Municipality of Pense No. 160 requires the sum of \$100,000 to meet current expenditures of the Municipality until the taxes for the current year are available;

AND WHEREAS the total taxes levied, or the estimated total taxes to be levied, for general municipal purposes for the current year, are \$3,217,544;

NOW THEREFORE be it resolved as follows:

- 1. That the Reeve and the Administrator of, and on behalf of, the said Municipality are authorized to borrow from the Conexus Credit Union 2006 (herein called "Conexus") the sum of \$100,000 to meet the current expenditures of the Municipality until the taxes for the current year are available and to pay interest thereon, or on so much thereof as remains from time to time unpaid, calculated at Conexus's prime interest rate per annum in effect from time to time plus 2 % per annum, as well as before maturity, default and judgement, with interest on overdue interest at the same rate as the principal.
- 2. That the sum so borrowed shall be repayable, including interest, within the current year, and shall be a first charge on all taxes levied for general purposes for the current year, which said taxes as collected shall be deposited with Conexus to the credit of the Rural Municipality of Pense No. 160.
- 3. That all arrears of taxes owing to the Municipality (excluding arrears of hail rates, school unit or town school taxes or taxes levied for the purposes of a health region, unless the liability of the Municipality in respect of the levy of such rates or taxes has been paid) are hereby hypothecated to Conexus as additional security for the repayment of the sum so borrowed including interest, subject to any previous charge affecting said taxes, and all moneys received upon the collection of said arrears shall be applied first in liquidating the liability of the Municipality to Conexus in respect of the said sum so borrowed.
- 4. That the Reeve and the Administrator of the Municipality are hereby authorized to execute under the corporate seal of the Municipality, a promissory note or notes in favour of Conexus for a sum or sums not to exceed in the aggregate the amount hereinbefore authorized to be borrowed and interest as aforesaid.
